Provided, That grantee shall accept said permission with the distinct understanding that it will stand full responsibility and save the City of Detroit harmless from any and all claims, damages or expenses that may rise by reason of the granting of said permission, and further

Provided, That this resolution is revocable at the will, whim or caprice of the Common Council and grantee hereby expressly waives any right to claim damages or compensation for
