ORDINANCE No. 276-D (File in container and make notation on page 44)

AN ORDINANCE to provide for the regulation of the use of water from the Detroit distribution system during the present national emergency. IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF DETROIT:

Section 1. The Board of Water Commissioners of the City of De-troit is hereby empowered during the present national emergency to adopt rules and regulations to curtail or restrict the use of water whenever necessary in the interest of the war effort, to conserve and protect said water supply for the users of the system and for the public peace, health and safe-

ty. Such rules as from time to time adopted shall be submitted time adopted shall be submitted to this Common Council for approval, and when so approved, proval, and shall be deemed to be a part

hereof.

Sec. 2. Said Board shall have
the right to discontinue service

Sec. 3. Any person violating the provisions of this ordinance shall provisions of this ordinance shall be deemed guilty of a misde-meanor and shall, upon convic-tion thereof in the Recorder's Court for the City of Detroit, be punished by a fine not to exceed one hundred (\$100) dollars, and in the imposition of such fine the Court may make a further sentence that the offender be imprisoned in the Detroit House of Correction for a period not to ex-

ceed ninety (90) days.

Sec. 4. All ordinances or parts
of ordinances in conflict herewith

are hereby repealed.

Sec. 5. This ordinance is hereby declared necessary for the preservation of the peace, health and safety of the City of Detroit and the citizens thereof and is hereby given immediate effect.
