**From City Plan Commission**

December 3, 1943.

To the Honorable, the Common Council:

Gentlemen—The Department of Public Works is desirous of obtaining more land adjacent to its 24th Street Garbage Station to permit an expansion of their garage facilities and to provide for a service building for the employees' use.

Adjacent to their present site there is a parcel of land described as Lot No. 7 of the Plat of the late Governor Porter, which is now in possession of the City of Detroit, having been acquired through tax foreclosure.

Our investigation has disclosed that a part of the above parcel would serve the need of the Department of Public Works as expressed and that such a

use of the land is the best apparent use to which it may now be placed.

The City Plan Commission therefore recommends that that portion of Lot No. 7 lying north of the Wabash Railroad right-of-way and extending to West Jefferson Avenue, approximately 100 ft. x 375 ft. in size, be allocated to the Department of Public Works for use in expanding its facilities as outlined.

**From City Plan Commission**

To the Honorable, the Common Council:

Gentlemen—The City of Detroit has recently obtained, by tax foreclosure,



a parcel of land 30 feet by 130 feet adjoining the existing Parks and Recreation playlot at the southwest corner of Sixth and Labrosse Streets.

We have received a request from that Department for the approval of the allocation of this parcel to them in order that it might be utilized as a part of this playlot.

While we are not certain at this time what the future pattern of this area is to be, there is a definite need for a recreational facility in this area.

Under the circumstances, the City Plan Commission approves the acquisition of this property for recreation purposes under Charter provisions and recommends that the west 10 feet of Lot 5 and the east 20 feet of Lot 6, Block 54 of the Subdivision of Labrosse Farm be allocated to the Department of Parks and Recreation for playground purposes.

To the Honorable, the Common Council:

Gentlemen—The City of Detroit is in possession of a lot on Nebraska Avenue immediately adjoining the Northwestern Playfield. This lot was obtained through tax foreclosure proceedings. We have been advised by the Department of Parks and Recreation that they can readily utilize this parcel in connection with Northwestern Playfield.

The City Plan Commission believes that the addition of this property to the Playfield would be desirable and hereby approves its acquisition for recreation purposes pursuant to Charter provisions.

The Commission therefore recommends that Lot 76 of Wm. Y. Hamlin's Subdivision be allocated to the Department of Parks and Recreation for playfield purposes.
