Gentlemen-May I request the ap-Council: proval of your Honorable Body, to enter into a month to month lease for a bay at the City Airport with the Atlantic Packaging Corporation. This company disassembles planes flown from the Consolidated Vultee Stinson Division at Wayne, Michigan, packages them, and sends them on their way by freight.

The City will receive \$650.00 per month rental for the bay and \$75.00 a day for the use of a crane and operator.
