ORDINANCE No. 397-D

Auditor General's Compensation

AN ORDINANCE to prescribe and fix the compensation for the office of Auditor General for the City of Detroit, as created by Chapter XXVII of Title IV of the Charter of the City of Detroit:

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF DETROIT:

Section 1. The compensation of the Auditor General of the City of Detroit as created by Chapter XXVII, Title IV, of the Charter of the City of Detroit, adopted by the people of the City of Detroit on June 25, A. D. 1918, and effective June 27, A. D. 1918, shall be and is hereby fixed in the sum of \$10.000.00 per annum for the term beginning August 1, 1944.

Sec. 2. This ordinance is hereby declared necessary for the preservation of the peace, health, safety and welfare of the people of the City of Detroit and is hereby given immediate effect.
