Mayor's Post War Improvement Committee

November 13, 1944.

To the Honorable, the Common Council:

Gentlemen-The Mayor's Postwar Improvement Committee begs to report to your Honorable Body relative to a change in the Advance Plan Program of the Zoological Park Commission.

On October 30, 1944 the Zoological Park Commission requested a change in their Advance Plan Project No. Z-8 "Australian Plain Exhibit" to include an additional estimated cost of \$12,000 for exterior work on the wall, guard rail, concrete pool and gunite work surrounding the building. An additional amount of \$7,500 estimated cost was also requested for landscaping the project when completed.
