**DUPLICATE DOG LICENSE TAGS**  
AN ORDINANCE to amend Chapter 67 of the Compiled Ordinances of the City of Detroit for the year 1936 and the amendments thereto, by adding a new section to be known as Section 3-A.

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF DETROIT:

Section 1. That Chapter 67 of the Compiled Ordinances of the City of Detroit for the year 1936, and the amendments thereto, be and the same

is hereby amended by adding a new section to be known as Section 3-A, reading as follows:

Section 3-A. Upon satisfactory proof that the check or disc issued by the License Collector as provided for in Section 3 of this ordinance, has been lost, the License Collector is hereby authorized to issue a duplicate check or disc upon the payment of the fee of ten (10c) cents to the License Collector.

Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**ORDINANCE NO. 433-D**

**BLACKOUT REPEAL**

AN ORDINANCE to repeal Ordinance No. 252-D, as amended by Ordinances No. 258-D, No. 279-D and No. 285-D, entitled: "An Ordinance providing for blackouts and air raid protection regulations affecting the conduct of persons, firms and corporations during blackouts and air raids; authorizing the Mayor to make certain rules and regulations involving the public peace, health and safety; defining offenses and prescribing penalties."

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF DETROIT:

Section 1. That Ordinance No. 252-D, as amended by Ordinances No. 258-D, No. 279-D and No. 285-D, entitled: "An Ordinance providing for blackouts and air raid protection regulations affecting the conduct of persons, firms and corporations during blackouts and air raids; authorizing the Mayor to make certain rules and regulations involving the public peace, health and safety; defining offenses and prescribing penalties", be and the same is hereby repealed.

Sec. 2. This ordinance is hereby declared necessary for the preservation of the peace, health and safety and welfare of the people of the City of Detroit, and is hereby given immediate effect.
