New York Central Railroad: Ac-New York Central Hairoad: Ac-knowledgement has been made of the receipt of returned form of agreement prepared by legal depart. ment of the New York Central Railroad. Agreement was returned by this office last week for the elimination or modification of a few profound to be objectionable from the City's standpoint. Further word in such respect is now awaited.

Detroit Terminal Railroad: Draft of an agreement covering an agreed upon one year's program involving eight streets, has been delivered by the General Manager of the Terminal to the legal department of the New York Central Railroad, as reported last week. No additional information concerning the progress of this agreement's being forwarded for the City's consideration was obtainable when contact was had with Mr. Smith of the Terminal on October 3rd.

Pennsylvania Railroad: Plans and estimates for the crossing protection to be installed by the Pennsylvania on its West Detroit Belt Line in the program were approved first year's by the Traffic Engineer, and this office has so advised the Railroad.

Grand Trunk Western Railroad: Continued progress is reported by the Railroad with respect to the modernization of the crossing protection along its Dequindre Line between Mack and Trombley. The work of installing concrete bases and wiring conduits continued last week at the Hancock and Forest crossings. As previously reported, the installation of manually controlled flashed signals in conjunction with short-arm gate attachments is now fully completed and in operation at the Trom-bley, Harper, Ferry and Warren Avenue crossings.

State Highway Department: This office has received notice from the Highway Department that a two day inspection of crossing protection and on the ground discussion of the subject is being arranged for October 10th and 11th, at State Trunkline highway crossings of various railroad intersections, requesting representation from this office. Such inspection and discussion is being undertaken as the initial step in the Highway De-Service Commission, signed by the partment's cooperation with the City
