Gentlemen-We are returning herewith petition of the Board of Education requesting the vacation of Faust and Penrod Avenues and the alleys easterly thereof, between Dover and Cathedral Avenues.

The vacation of said streets and alleys was approved and recommended by the City Plan Commission in their communication to your Honorable Body of October 10, 1946, and the petition was then referred to this office by your Committee of Whole for investigation and report.

We wish to advise that all of our investigations have been completed.

The Board of Education was informed of the reimbursements to be made the various City departments affected by the vacation of above mentioned streets and alleys, and, at their meeting of September 23, 1947, approved the payment of the following amounts:

- a) \$250.00 to the City Treasury to be credited to Fire Department Fund Code No. 106-9400-0, said amount being the estimated cost of relocating a fire hydrant on the northeast cor-ner of Penrod and Dover Avenues.
- b) \$705.60 to Permit Division of D. P.W. to cover the estimated cost of constructing approximately square feet of sidewalks at the intersection of all streets and alleys to be vacated.
- c) \$400.00 to the Permit Division of the D.P.W. to cover the cost of con-structing two sewer manholes in Dover Avenue, necessitated by the vacation of the streets and alleys in question.

We have received word from the Department of Water Supply that in addition to the payment of the sum of \$3,000.00 to cover the estimated cost of abandoning that department's water main in Faust Avenue and necessary new construction, a satisfactory right-of-way was received for the maintenance of the water mains in the portion of Penrod and Rosemont Avenues to be vacated.

All other City departments and private utility companies reported that they will be unaffected by the of said streets and alleys v cotion or that they will remove their installations at no cost to the petitioners.

In view of the above, we recom-

mend the adoption of the attached resolution.
