The schedule below refers only to specific progress that has been made

during the present week.

Detroit Terminal Railroad: print plans of the improvements scheduled in 1947, which were submitted by the railroad for the City's approval, have been found acceptable by the City Traffic Engineer and are being returned to the railroad with his signature of approval denoted thereon.

Pennsylvania Railroad: The installation of the concrete bases and electrical conduit work for the new protection devices at the Schaefer and Meyers Road crossings is now completed. pleted, and is 50% completed for the

W. Chicago Avenue crossing.

A field inspection of these three crossings was made on January 30th by Mr. Homer Hughes of the Michigan Service Commission with representatives of the City and railroad in attendance. New York Central Railroad: Advice solicited from Mr. H. P. Stacey, General Attorney for the railroad, are to the effect that plans for the crossing protection program for 1947 are completed for attachment to the joint application form addressed to the Mich. Public Service Comm. which has been signed in behalf of the railroad, and is just being forwarded to the City for similar action and dispatch to Lansing. We are also advised that the City's copy of formal agreement for the two year grade crossing protection program is fully executed and being mailed today.
