Gentlemen—We are returning herewith petition of the Ebling Creamery Co. and Kramer Bros. Freight Lines, Inc. (No. 3447), requesting the vacation of a 20-foot north and south public alley in block bounded by 24th Street, 23rd Street, Fort Street and Savoy Avenue.

The vacation of this alley was ap-

proved and recommended by the City Plan Commission in their communication to your Honorable Body of December 27, 1946, and the petition was then referred to this department by your Committee of the Whole for further investigation and report.

We wish to advise that all of our investigations have been completed. On May 20, 1947, Kramer Bros. Freight Lines, Inc., made the following payments into the City Treasury: a) \$670.00, Receipt No. 56718, credited to Public Lighting Commission Fund Code No. 123-9300-0-9, said amount being the estimated cost of rerouting P. L. C. overhead line facilities necessitated by the vacation of said alley; b) \$37.56, Receipt No. 56719, credited to Public Works Maintenance Fund Code No. 143-6221-1, to reimburse the City of Detroit for the original cost of paving the 20-foot east and west public alley north of Fort St. at the intersection of the alley requested to be vacated.

On May 20, 1947, Kramer Bros. Freight Lines, Inc., also deposited the sum of \$48.00 to the Permit Division of the Department of Public Works, Receipt No. 66486, said amount being the estimated cost of constructing a sidewalk on the south side of Savoy Avenue at the intersection of the alley requested to be vacated.

All other City departments private utility companies reported that they will be unaffected by the proposed vacation, or that they have reached satisfactory agreements with the petitioners regarding their installations in said alley.
