Dear Sir—Attached is a tabula-tion showing the status of agreement negotiations with all the Railroads for a program of improved crossing protection as of this date.

The following report refers to specific construction progress that has been made during the current week. Pere Marquette Railway: Final

completion of the protection installation at the Joy Road and Livernois crossings on the West Detroit Branch Line has been accomplished and same are in operation at both locations.

Work has again been resumed at the Greenfield crossings on the Main Line and the completion percentage

was increased from 33 to 40.

The lack of materials is still responsible for the lack of progress to be noted in connection with the other three main line installations of modernized protection planned for Joy Road, Burt and Evergreen Roads.

New' York Central Railroad: A signal gang has made concentrated ef-forts to effect the installation of new equipment scheduled for the protection of the Central Avenue and Lonyo Road crossings on the Main Line, and as a result the percentage of completion in each instance was advanced 5%, so that the Central Avenue work is now 75% finished and Lonyo 65%.

We are advised that the railroad has not as yet received notification of the shipment of long awaited materials to be used at the Mt. Elliott crossing installations, although some was scheduled to take place on November 17th.

Department of Buildings and Safety lerton crossings of this Railroad's Belt Line. The installations have been completed these several past weeks, and will now be promptly placed in effective operation as the result of the issuance of the above order.

Warren Avenue and Ryan Road crossings for the protection equipment programmed for installation during this year, according to the agreement terms. Forms are ready for the Dequindre Street crossing and will be poured tomorrow (Saturday). The lack of pipe conduit and electric cable is hampering progress at all locations where work has been started, and in consequence the signal gang is performing the concrete work at the various crossings scheduled, before the advent of bad weather. We are informed that an attempt will be made to secure pipe conduit locally so that same can also be installed before adverse weather sets in.
