Gentiemen—Petition No. 521, filed by Fred T. Barton, et al, requesting the vacation of certain portions of Pickford Avenue between Evergreen Avenue and Grandville Road, and the petition of the Department of Parks and Recreation requesting the vacation of Plainview, Westmoreland, Annchester, Edinborough and Huntington Roads and the alleys adjoining, between Curtis and Pickford Avenues, were referred to this office by your Committee of the Whole for investigation and report.

The vacation of said streets and alleys was previously approved and recommended by the City Plan Commission.

Please be advised that all of our investigations have been completed, and we found the following City departments affected by the vacation of said streets and alleys: Public Lighting Commission (poles and wires); Department of Water Supply (water mains); Fire Dept. (hydrants); Department of Public Works (sewers). Proper provisions are incorporated in the vacating resolutions protecting the interests of these departments in their installations in said streets and allevs.

As to the vacation of the north and south streets and alleys, above mentioned, within the limits of the re-cently acquired recreational sites, the only private utility company affected thereby is the Detroit Edison Company, and they have agreed to remove their installations therefrom at

no cost to the City. As to the vacation of Pickford Avenue, above mentioned, all the private utility companies reported that they have reached satisfactory agreements with the petitioner (Fred Barton, et al) as to their installations in said Pickford Avenue
