Honorable Common Council:  
Gentlemen—Under date of July 25, 1950 your Honorable Body authorized the purchase of eighty (80) Trolley Coaches from the St. Louis Car Company.

It is now deemed advisable to install an additional stanchion at the front end of the coaches which would provide distinct separation of the traffic flow at the front door. Experience with the present equipment has indicated, by the addition of these stanchions, traffic would be so directed as to prevent any loss of fares.

The St. Louis Car Company agrees to furnish and install the stanchions for \$22.50 per coach and it is recommended that we be permitted to issue a purchase order for this installation, the total cost of which will be \$1,800.00.

The approval of your Honorable Body is requested.

Honorable Common Council:  
Gentlemen—We respectfully submit the financial statement of the Department of Street Railways for the month of October, 1950:

Revenue and Expenses:

Gross revenue for the month amounted to \$3,975,687.88. Of this \$3,969,748.33 is recorded as operating revenue. Total expenses amounted to \$3,922,611.81, of which \$3,429,493.36 represents operating expenses. The remaining \$493,118.45 represents fixed charges, including depreciation, taxes, and interest.

Compared with October, 1949, the operating revenue for October, 1950, shows an increase of \$357,490.32, while the operating expenses show an increase of \$189,904.62.

Profit or Loss:

The operation showed a profit of \$53,076.07 for the month. The loss for October, 1949 was \$139,653.19.

Passengers Carried:

39,730,408 passengers were carried. Of these, 28,669,816 were revenue passengers and 11,060,592 transfer passengers.

In comparing October, 1950 with the same month in 1949, it should be borne in mind that the Department's contribution to the employe's retirement fund now amounts to \$242,292 monthly, an increase of \$36,000 per month over last year.

At the same time, the number of people using the Department's facilities continues to decline. The system carried 886,905 fewer revenue passengers last month than it did in October, 1949.
