Honorable Common Council:

Gentlemen-We are returning herewith the petition of Frank R. Gerbig et al (No. 2204), requesting the vacation of certain alleys north of Fort Street and west of Twenty-second Street. The vacation of said alleys was approved by the City Plan Commission in their communication to your Honorable Body of September 7, 1950, with the recommendation that the petitioners deed an alley outlet in lieu of the alleys to be vacated. Your Committee of the Whole then referred the petition to this office for investigation and report.

Please be advised that our investi-

gations are completed.

As per our directive, on November 1950, the petitioners deposited with the Permit Division of the Department of Public Works, the sum of \$425.44, Receipt No. 17972, said amount being the estimated cost of "closing" the vacated alley and improving the newly deeded alley.

We are in receipt of a Quit Claim deed whereby land is deeded for alley purposes in accordance with the City Plan Commission's recommendation. Said deed was approved by the Corporation Counsel as to form and execution and by the City Engineer as to description and it is attached hereto for your Honorable Body's acceptance.

In reply to our inquiries all other City departments and privately owned utility companies reported that they will be unaffected by the vacation of said alley or that they have reached satisfactory agreements with the petitioners regarding their installations therein.

We recommend the adoption of the attached resolution.
