tion with the preliminary documents appeared to be more in the nature of an amendment to each of the respective contracts than change orders covering extra drafting services contemplated when the respective contracts were signed.

Based on the estimated improvement costs of the parts of the projects not yet built (\$8,000,000 for Douglass, Mich. 1-8, and \$17,000,000 for Jeffries, Mich. 1-7) and on the schedule of fees for architectural services set forth in the formula and rules prescribed by the Public Housing Administration for such services, the amount of the change order to Harley, Ellington & Day's contract for Bid Areas No. 2 and No. 3 of the Frederick Douglass Apartments is \$23,-801 and the amount of the change order to Amedeo Leone's contract for Bid Areas No. 2, No. 3, and No. 4 of the Edward J. Jeffries Homes is \$35,075.

We request approval of the above change orders to the contracts of Amedeo Leone, Architect, and of Harley, Ellington & Day, Inc., Architects. Respectfully submitted,
