Gentlemen-For several years there has been an acute shortage of qualified engineers.

The Department and the Civil Service Commission have inaugurated from time to time, training programs for engineering students, and although these programs have helped we are still unable to secure a sufficent number of Engineers to meet

our requirements.

In order that we may go further into this training program the Civil Service Commission has recommended that a new class known as "Civil Engineering Scholar" be set up which would include civil engineering stu-dents enrolled in universities who would rotate their time between their university and the Department on a three month basis. Continuance in this program would be subject to students maintaining a satisfactory scholastic standing and also a satisfactory work record with the Department.

At the completion of their education and their training with the Department these students would then be available for promotion to regular

engineering classifications. In order that this program may be put into operation it is necessary that a new classification of "Civil Engineering Scholar" be set up in our memo-salary account and also

that the official compensation schedule be amended to include this classification.

If your Honorable Body is in agreement with our recommendation, may we have your approval of the following resolution.

ing scholarship in Civil Engineering." Eligibility — For Application—limited to Civil Engineering students who are completing or who have completed their second (Sophomore)

For Employment - limited to third year (Junior) or higher students in Civil Engineering.

Contingent on successful continu-

ance of studies on a part-time basis.

Work Assignments—to be a three year program of part - time work either:

Three months assigned to work 1. and three months in school.

One semester assigned to work and one semester in school (it is contemplated that participants will work alternate summers and attend school alternate summers and that they enroll for at least one course in night school during their semester of assignment to work.)
