Honorable Common Council:

Gentlemen—We are returning

herewith the petition of the McLouth Steel Corporation (No. 4108), requesting the vacation of the north 5 feet of South Street between the west line of vacated Infantry Avenue and the west line of Livernois Avenue. The vacation of said portion of street was approved by the City Plan Commission with the recommendation that the petitioner deed to the City a strip of land to straighten South Street between Crawford Avenue and vacated Infantry Avenue. The petition was then referred to this office by your Committee of the Whole for investigation and report.

We wish to advise that our investigations are completed.

As per our directive, on February 24, 1953, the petitioner deposited with the Permit Division of the Department of Public Works the sum of \$1,317.00, Receipt No. 42895, said amount being the estimated cost of relocating sidewalks necessitated by the vacation and dedication of street.

We are in receipt of a Warranty Deed to the land to be used for street purposes as per City Plan Commission's recommendation. Said deed was approved as to form and execution by the Corporation Counsel and as to description by the City Engineer and it is attached hereto for your Honorable Body's acceptance.

In reply to our inquiries all other City departments and privately owned utility companies reported that they will be unaffected by changes brought on by the vacation of said portion of street, or that they have reached satisfactory agreements with the petitioners regarding their installations.

We recommend the adoption of the attached resolution.

Resolved, That the north 5.00 feet of South Street (60 feet wide), lying south of and adjoining the south line of lots 179 to 188, both inclusive, and extending from the west line of Livernois Avenue (66 feet wide), to the west line of vacated Infantry Avenue (33 feet wide) as platted in Daniel Scotten's Subdivision of that part of Private Claim 32 and the east 735.90 feet of Private Claim 268 lying between Fort Street and the River Road, T. 2, S., R. 11 E., as recorded in Liber 9, Page 19 of plats, Wayne County Records, being a strip of land 5.00 feet wide x 324.78 feet long, be and the same is hereby vacated as a public street to become a part and parcel of the adjoining property; and further,
