C.'s 9 and 454, lying west of McDougall Ave. between the extended south line of the 20 foot eastwest alley north of Larned St. and the north line of Larned St. 60 feet wide, described as follows: Beginning at the southeast corner of Lot 15 of Sub-division of Block 15, Joseph Campau Farm, P.C. 609, as recorded in Liber 1, Page 266 of Plats, Wayne County Records; thence along the east line of said lot 15, N. 25 deg. 59 min. 45 sec.
