The Drawings for the Substructure Contract provided that pockets were to be left in the concrete motor floor for the steel columns that were to be furnished and set under the Superstructure Contract. After the columns were set, the pockets required a concrete fill. Neither the Superstructure Contract nor the Substructure Contract required such fill.

It was determined that it would be more efficient, and involve the least cost, to have the fill made by Substructure Contractor, the Kenny Construction Company. This Contractor has submitted a price of \$1,544.06 for this work which has been checked and found to be correct, fair, and reasonable for the work involved. It is, therefore, recommended that this extra work be added as an addition

to the existing Contract, PW-1071-B2. It is our understanding that funds are available in Account No. 925-2390-931.
