Gentlemen-Your Committee of the Whole referred to this office for investigation and report the petition of the Detroit Construction Company, Petition No. 4685, requesting the vacation of Rockdale Avenue, from the south line of Outer Drive to the north line of Glendale Avenue. The vacation of said street was approved by the City Plan Commission.
We wish to advise that our in-

vestigations are completed.

As per our directive, on March 26, 1954, the petitioner deposited into the City Treasury the sum of \$1,989.28, Receipt No. B 41508, credited to Department of Water Supply, Code No. 601-9300-0-6290-608, said amount being the estimated cost of abandoning the water main in said street, and the reimbursement for their remaining equity in the water main to be abandoned.

A proper provision is incorporated into the vacating resolution protecting the City's interests in the sewer and water main located in the portion of Rockdale Avenue to be vacated.

All other City departments and privately owned utility companies reported that they will be unaffected by the vacation of said street, or that they have reached satisfactory agreements with the petitioners regarding their installations therein.

We recommend the adoption of the

Resolved, That all of Rockdale Avenue, 60 feet wide, between the north line of Glendale Avenue and the south line of Outer Drive, as platted in Grayton Park Manor, being a subdivision of part of the N.E. ¼ of Section 28, and part of the N.W. ¼ of Section 27, T. 1 S., R. 10 E., Redford Township Wayne Causty Mich. ford Township, Wayne County, Michigan, as recorded in Liber 52 of plats, Page 89, Wayne County Records, lying east of and adjoining the east line of Lots 192 to 207 both inclusive, east of and adjoining the east line of Lot 242, east of and adjoining the 18 foot easement between Lots 207 and 242, west of and adjoining the west line of Lots 208 to 223 both inclusive, west of and adjoining the west line of Lot 241, west of and adjoining the west line of the 18 foot easement between Lots 20 8and 241 of last mentioned subdivision, be and the same is hereby vacated as a public street to become a part and parcel of the adjoining property subject to the following provisions:

2. No buildings or structures of any nature whatsoever shall be constructed over said easement unless prior approval therefor shall be obtained from the Department of Water

Supply; and further,
3. Provided, That by reason of the vacation of the above described street, the City does not waive any rights to the sewers located therein, and at all times shall have the right to enter upon the premises, if found necessary, on account of said sewer to repair, alter or service same; and further,

4. Provided, That if a building is

to be constructed over said sewer, the sewer shall be replaced with cast iron pipe of the same size, rerouted or encased in 6 inches of Class A concrete, or in lieu of the above, such work shall be done as will be specified by the City Engineer, all of the work mentioned to be done under the supervision and inspection of the Depart-ment of Public Works and all the costs to be borne by the petitioners, their successors, or assigns; and further

5. Provided, That no buildings shall be constructed over said sewers with-out the prior approval of such build-ing construction by the City Engineer.
