**Streets and Traffic**

June 10, 1955.

Honorable Common Council:

Gentlemen—Investigation has disclosed a rather serious accident condition at the intersection of Woodward and Ralston Avenues. This is due to Ralston being used as a by-pass route for traffic desiring to go from State Fair Avenue to Woodward Avenue in an attempt to avoid the traffic signal at the intersection of Woodward and State Fair. Southbound traffic on Ralston from State Fair to Woodward is required to cross the heavy northbound Woodward Avenue traffic in order to proceed south on

Woodward or to continue west through the Palmer Woods section. This latter movement has also been objected to by residents of the area.

In order to remove this accident hazard and divert this by-pass traffic to its normal and proper route, the Commission of Streets and Traffic has approved the making of Ralston Avenue a one-way northbound street between Woodward and State Fair. It is respectfully recommended to your Honorable Body that approval be given to this change.

**Streets and Traffic**

Honorable Common Council:

Gentlemen—We have received a request from Mrs. Harold Hayes, 14564 Chatham for permission to install a sign reading "Children Play Here—Slow" on Chatham at Lyndon and at Wannamaker.

We would recommend that your Honorable Body grant this permission to the petitioners represented by Mrs. Harold Hayes in line with the established policy as follows:

1. The signs to be used shall be the standard sign, the message of which is given above, and a drawing of which we will furnish the petitioners.

2. The signs are to be purchased, installed and maintained at the petitioners expense, and shall be located from 3 ft. to 10 ft. from the curb of the street on which installed and from 40 to 70 ft. from the nearest intersection. The bottom of the sign shall be 7 ft. from the ground.

3. The petitioners should be advised that these signs are intended as a safeguard only. They do not imply use of the street as a playground.
