The fourth quarter showed a decrease of 0.04 of a day per salary employee, and an increase of 0.09 of a day per hourly employee, when

compared to the fourth quarter of the 1953-54 fiscal year.

For the entire 1954-55 fiscal year, salary employees used an average of 8.05 days of sick leave per employee, which is a decrease of 0.44 of a day per employee, when compared to the per employee when compared to the 1953-54 fiscal year.
