Gentlemen—Your Committee of the Whole referred to this office for investigation and report the petition of Michael Manoojian, No. 3373, requesting the vacation of a portion of Davison Avenue right-of-way between LaSalle Avenue and the alley first easterly thereof.

We wish to advise that our investigations are completed.

The petitioner deposited with this office the sum of \$54.26, to reimburse the City of Detroit for the original cost of paving the east ½ of LaSalle Avenue at the intersection of the area to be vacated. In the event the attached resolution is adopted the above amount will be paid into the City Treasury, credited to the Public Works Maintenance Fund, Code No. 143-6221-1. If the above request is denied, the amount of \$54.26 will be returned to the petitioner.

In reply to our inquiries all other City departments and privately owned utility companies reported that they will be unaffected by the vacation of said portion of street.

This office concurs with the recommendation of the City Plan Commission that this petition be denied.
