The above listing is slightly different from that appearing in the current directory. Under departmental listings, if a department's night number is different than its regular number, this notation will be shown in the directory. Many of the departments, however, do not normally operate on Saturdays or after-hours. In special situations where a department may be working overtime, an emergency line on which employees may be contacted is provided. This, however, is not listed in the directory. For specific situations, when many calls from the public may be expected, arrangements could be made with the Telephone Company to man the switchboard in the City-County Building.

Re: Revocable Permit for North End Postal Station Site.

Gentlemen—Under date of January 6, 1956, the General Services Administration of Chicago wrote to us regarding the alley between Baltimore, Milwaukee, Woodward, and John R claiming that the Federal Government was the owner of the property and that people had been ticketed by the Detroit Police Department for parking in said alley. We checked the records in the City Engineer's Office which showed that the alley had never been closed. We advised the General Services Administration under

date of January 13, 1956, that the Police Department would continue to exercise jurisdiction over said alley until it was properly closed.

It develops that in 1940, the alley was included in the petition for the condemnation of the property for a Post Office site. Under date of February 23, 1940, J.C.C. 434, your Honorable Body authorized the acceptance of the sum of \$200 for relocating a manhole cover pursuant to a stipulation entered into by this office and the United States District Attorney's Office. The acceptance of this sum also included our right and title in the alley. In 1942 the Federal Government, by decree, entered in Federal Law Case No. 15569, confirmed the condemnation of the alley. Nothing further was done.

We are now in receipt of letter dated February 23, 1956, from the General Services Administration to the effect that they will grant us a revocable permit over the condemned land for means of ingress and egress, being the east twenty feet of Lot 72 of Patrick McGinnis Subdivision, for

City's purposes.

We deem it to the best advantage to the City of Detroit to accept this revocable permit and ask your Honorable Body to authorize the acceptance of the same.
