Gentlemen — This office retained Mr. A. R. Douglas, Q.C., Barrister & Solicitor in London, Canada, to handle the claim of the City of Detroit for taxes assessed to Riverside Poultry for the year 1954 for \$273.74 exclusive of interest. Suit was started in the County Court of the County of Middlesex, Canada, against H. Bidderman and Leo Goodman, doing business under the name and style of Riverside Poultry, defendants, to enforce payment of the above taxes.

Pursuant to an order of said court entered on application of the solicitors for the defendants, the City of Detroit filed in said court a bond for \$200.00 as security for defendants' costs. Defendants claim the property assessed for the above taxes consisting of poultry purchased in Detroit failed to comply with the standards of the Department of Agriculture of
