deduction in the Assessment Portion of \$159.00 resulted. This amounts to 6 percent of the Assessment Portion of the construction costs.

It is recommended that the adjustment be made by deducting the \$159.00 from the City Intersection Portion and that the Assessment Portion remain unchanged.

Gentlemen-We are returning herewith the petition of the Chrysler Corporation (No. 10421) requesting the vacation of portions of Gable, Dwyer, and Hamlet Avenues and certain alley south of Eight Mile Road east of Mound Road. The vacation of said portions of streets and alley was approved by the City Plan Commission and the petition was then referred to this office by your Committee of the Whole for investigation and report.

We wish to advise that our investi-

gations are completed.

As per our directive, the petitioners deposited with the City Treasurer the sum of \$1,964.87, Receipt No. C-15646, credited to the Department of Water Supply Fund Code No. 600-0000 (6232)001, said amount being the estimated cost of the work necessary to abandon water mains, and the re-

maining equity in the mains to be abandoned, necessitated by the vacation of said portions of streets.

All other City departments and privately-owned utility companies reported that they will be unaffected by the vacation of said portions of streets and alley, or that they have reached satisfactory agreements with the petitioners regarding their installations therein.
