Department of Justice requesting the vacation of Iowa Avenue between

Sherwood Avenue and the Michigan Central Railroad Right-of-Way. The vacation of said street was approved by the City Plan Commission and was then referred to this office by your Committee of the Whole for investigation and report.

We wish to advise that our investi-

gations are completed.

A resolution was adopted on June 21, 1955, J.C.C. Page 1289, for the widening and opening of Sherwood Avenue between Davison and Seven Mile Road. The easterly 35 feet of the land owned by the government is required for the above widening.

We have been advised by the Bureau of Real Estate Division of the Corporation Counsel's Office that the United States Department of Justice and the Public Housing Administration are favorable to the dedication of the land required for the widening of Sherwood Avenue in lieu of the vacation of said Iowa Avenue.

All City departments and privately owned utility companies reported that they will be unaffected by the vacation of said street.
