Gentlemen — Gertrude Gordon, of 18619 Washburn was injured on Youngblood, and President Miriani-8. January 29, 1953, by reason of a defective condition of the sidewalk on the south side of Margareta Avenue, between Wyoming and Washburn, and it was alleged that the defect was in Honorable Common Council: excess of 2 inches deep.

On December 17, 1954, the matter was referred to your Honorable Body with the recommendation of "denyno liability" and was based on our investigation which indicated that the defect was not culpable, and for the further reason that the injured was guilty of contributory party negligence.

Subsequently, suit was started in ne Wayne Circuit Court and came on for trial on March 22, 1957; at which time, a discussion was had as to settlement of the claim of Gertrude Gordon as well as the claim of Sam Gordon, who had filed a claim and action for his costs in caring for his injured wife which was placed at \$4,395.00. After some discussion on this point, the plaintiff agreed to settle for the sum of \$400 for both

In view of the factual evidence involved, we believe that the acceptance of this offer of settlement is in the interest of the City of Detroit; and we recommend such acceptance and request your Honorable Body to direct the City Controller to draw a voucher in favor of Gertrude Gordon, Sam Gordon, and Herbert Pevos, attorney for the said plaintiffs, to be delivered upon receipt of proper releases and satisfactory to this office.
