Honorable Common Council:

Gentlemen-We are returning herewith the petition of the City Bank, No. 11691, requesting the conversion into an easement of the alley east of Cadieux Avenue and north of Mack Avenue. The petition was approved by the City Plan Commission with the recommendation that sufficient land be deeded to the City for a new alley outlet into Cadieux Avenue. The petition was then referred to this office by your Committee of the Whole of investigation and report.

We wish to advise that our investigations are completed.

As per our directive, on April 16, 1957, the petitioner deposited with the Permit Division of the Department of Public Works the sum of \$1,500.00, Receipt No. 80517, said amount being the estimated cost of paving newly deeded alley and installing a new alley return at the entrance thereto.

We are in recipt of a Warranty Deed whereby petitioner dedicated land for an alley outlet in accordance with the City Plan Commission's recommendation. Said deed was approved as to description by the City Engineer and it is attached hereto for your Hon-

orable Body's acceptance.

The petitioners have also offered to grant easement rights to the remaining property owners on the Mack Avenue frontage over a driveway that will be constructed along the east boundary of petitioner's property. They have further offered to record said easement. This driveway will extend south from the alley back of the Mack Avenue frontage out to Mack Avenue.

All other City departments and privately owned utility companies reported that they will be unaffected by the change or that they have no objections to the conversion of the alley to an easement provided that proper provisions are incorporated into the vacating resolution protecting their interests in the installations located in the alley.

We recomend the adoption of the attached resolution.
