Honorable Common Council:

Gentlemen—The State Highway Department has requested that the City of Detroit participate with them in the cost of widening Eight Mile Road (M-102) from Five Points Avenue to an approximate Southfield Road, length of 31/2 miles.

Over a period of years, a third lane has been added to each roadway of the Eight Mile Road, which work has been done in stages. This is the last remaining section of Eight Mile Road, which requires widening from a twolane roadway to a three-lane road-way. Because of the volumes of traffic, we feel that this is a necessary and desirable improvement.

The widening will consist of adding 16 ft. of pavement plus curb and gutter, to be built along the center median of the present Eight Mile Road. Thus, no property will be required. The traffic lanes will each be 12 ft. wide rather than the present 10 ft. wide lanes, and the entire surface will be covered with bituminous concrete.

Inasmuch as this project was initlated after our budget for street improvements was prepared, may we request that transfer be made from

available funds.

The State intends to do this work as a part of the 1958 Federal Highway provisions which allocated emergency funds. In this case, the federal-aid will amount to 2/3 of the total cost, with the balance to be apportioned between the State and the City in accordance with present highway laws. The total estimated cost for the portion in Detroit is \$368,000.00. After deducting 2/3 of this cost for federal-aid participation, the City would pay 25% of the balance, or approximately \$31,000.00.

In view of the above, we recom-

mend the adoption of the attached resolution.
