We wish to advise that our in-

vestigations are completed.

As per our directive, the petitioner deposited with the Permit Division of the Department of Public Works the sum of \$5,900.00, Receipt No. GR 4653, said amount being the estimated cost of removing concrete base and asphalt surface, constructing curb and walk, adjusting one manhole and

backfilling where necessary.
On July 29, 1960, the petitioner deposited with the City Treasurer the sum of \$650.00, Receipt No. C 3316, credited to the Detroit Fire Department Fund Code No. 990-9406, said amount being the estimated cost of removing one hydrant and relocating one hydrant in the portion of Ray-

one hydrant in the portion of Raynor Avenue to be vacated.
