Gentlemen-We wish to advise that in carrying out the development plan for the rehabilitation of the blighted area which is known as the Lafayette Project, which is being undertaken by the City pursuant to Act 344 of Public Acts of 1945, as amended, the Detroit Housing Commission has requested the vacation of certain streets and alleys bounded by the Walter P. Chrysler Expressway, Lafayette, Grand Trunk Railroad and Jefferson Avenue being within the limits of the above mentioned project.

The Detroit Edison Company has reported that it has lines and poles in the streets and alleys to be vacated and has submitted an estimate of \$56,218.19, as its entire cost of removing and rerouting its installations from the streets and alleys to be vac-

streets and alleys to be vacated.

We have been advised by the Office of the Corporation Counsel that since the vacation of these streets and alleys are necessary to carry out the development plan for the rehabilita-tion of this blighted area, that the relocation costs of these utilities is not chargeable against the City.

All other City departments and privately owned utility companies re-ported that they will be unaffected by the vacation of said streets and

alleys.

In view of the foregoing, it will be necessary to adopt a resolution vacating the aforementioned streets and alleys and directing the Detroit Edison Company to remove their lines and poles therefrom.

Honorable Common Council:

Gentlemen — This is in reply to a letter from the City Clerk of September 20, 1961, in which you requested our comments about including in the Street and Alley Paving 30-Day Notice a statement to the effect "that any protest should be made to the Common Council in writing within 60 days." It is believed desirable and is recommended that the filing of protest petitions be limited to a 30-day period immediately following the date of publication of the "Street and Alley Paving 30-Day Notice." This limitation could be made a part of the Notice by adding the following sentence: "Any petition protesting the proposed paving must be filed with the Common Council within 30 days of this notice."

It is felt that such provision would result in clearing all protest petitions prior to the actual opening of bids and would eliminate cancellation of awarded or confirmed contracts as has occurred in the past.

We recommend a 30-day notice instead of a 60-day notice as we feel that 30 days is sufficient to file a protest and any additional time allowed could result in the holding up of needed improvements.

In regard to your question as to the liability to the City if a paving contract was stopped, we believe that this is a legal matter which may best be answered by the Corporation Coun-
