Gentlemen—On July 26, 1955, the Wayne County Circuit Court entered judgment in favor of the City of Detroit and against William C. Davids, Law Action No. 274 921, in the amount of \$527.85 plus \$24.00 costs, for failure to pay 1951 personal property taxes.
