with the petition of Harry Slatkin Builders, Incorporated, No. 8960, requesting the vacation of the eastwest public alley south of Plymouth Road between Rutland and Memorial Avenues. The vacation of said alley was approved by the City Plan Commission with the recommendation that the alley right-of-way will be returned to the City of Detroit in the event there is a change in the area which creates a need for the alley. The petition was then referred to this office by your Committee of the Whole for investigation and report.

We wish to advise that our investi-

gations are completed.

The petitioner has submitted to the City of Detroit an agreement whereby they will return the vacated alley back to the City in the event there is a change in the area which creates a need for the alley Said agreement was approved by the Corporation Counsel with the recommendation that the agreem nt be recorded with the Register of Deeds Office upon adoption by your Honorable Body a resolution vacating the above mentioned alley.

The petitioner deposited with the

Receipt No. A25250, credited to the Public Works Street Maintenance Fund Code No. 143-6241, said amount being the original cost of paving the ast half of Rutland Avenue and the west half of Memorial Avenue at the intersection of the alley to be vacated.

Proper provisions are incorporated into the vacating resolution protecting the City's interests in the sewer located in the above mentioned alley to be vacated.

All other City departments and privately owned utility companies re-ported that they will be unaffected by the vacation of said alley or that they have reached satisfactory agreements with the petitioner regarding their installations therein.

R. 10 E., City of Detroit, Wayne County, Michigan as recorded in Liber 71, Page 13 of Plats Wayne County Records lying south of and adjoining the south line of Lots 25 to 37 both inclusive and north of and adjoining the north line of Lots 24 and 38 all of the above mentioned subdivision.

Be and the same is hereby vacated as a public alley to become a part and parcel of the adjoining property, subject to the following provisions:

- 1) Provided, That by reason of the vacation of the above-described alley, the City of Detroit does not waive any rights to the sewer located therein and at all times shall have the right to enter upon the premises, if found necessary, on account of said sewer to repair, alter, or service same; and fur-
- 2) Provided, That if a building is to be constructed over said sewer, the sewer shall be replaced with cast tron pipes of the same size, rerouted or enclosed in 6 inches of Class "A" concrete, or in lieu of the above, such work shall be done as well as will be specified by the City Engineer, all of the work mentioned to be done under the supervision and inspection of the Department of Public Works and all costs entailed, to be borne by the petitioners, their successors, or assigns; and further;
- 3) Provided, That no buildings shall be constructed over said sewer without the prior approval of such building construction by the City Engineer and the Department of Buildings and City Treasurer the sum of \$389.29, Safety Engineering; and further;

4) Provided. That in the event that the sewer located in said alley, if built upon, shall break causing damage to any construction above, the petitioner and their assigns, by acceptance of the permit for building over said sewer, waive all claims for damages to such construction and agree to pay all costs incident to the repair of said broken sewer; and further;

Resolved. That the agreement by the petitioner and the City of Detroit whereby petitioner will return to the City the above mentioned vacated alley, be recorded with the Register of Deeds for Wayne County.
