Surplus Real Property Committee
 Petition No. 9520
 Honorable Common Council:
 Gentlemen—We are returning herewith Petition No. 9520 by Federal-Mogul-Bower Bearing, Inc., requesting the vacation of an easement on a portion of the Petitioner's property, adjoining the City of Detroit's Hern Yard property.
 The easement was established by the former owners of the property for the purpose of access between the Detroit Terminal Railroad right-of-

way and a portion of the city-owned land now known as Hern Yard, said easement rights having passed to the City of Detroit through acquisition of said lands by condemnation proceedings (Recorder's Court File No. 1785).

The Surplus Real Property Committee has reviewed all the statements set forth in the petition, and concurs with the City Plan Commission opinion (attached) that the vacating of the easement would not create any hardship in the future use of the so-called Hern Yard, which is now surplus property and for sale.

The Petitioners have submitted a supplement to their petition (attached) granting the City of Detroit the right to continue an encroachment on their property, caused by the construction of a building on the Hern Yard by the City of Detroit and which building encroaches upon the Petitioner's property to the extent outlined in their supplementary petition.

In view of the above, the Surplus Real Property Committee recommends that the petition be granted, and respectfully requests that your Honorable Body directs the Corporation Counsel to prepare the necessary documents to effect the vacating of the easement, incorporating therein the reservation of the building encroachment by the City of Detroit, and further that the City Controller be authorized to execute the documents on behalf of the City of Detroit.
