Gentlemen — Your Committee of the Whole referred to this office for investigation and report, petitions requesting conversion into easements of the alleys described in the attached resolution.

The conversion of the alleys into easements was approved by the City Plan Commission at an earlier date.

We wish to advise that our investigations are completed. In reply to our inquiries, all City departments and privately owned utility companies reported that they have no objections to the conversion of the alleys into easements, provided that proper provisions are incorporate into the vacating resolution protecting their interests in the installations located in the alleys.

Resolved, That all that part of the north-south public alley, 20 feet wide, north of Geitzen Avenue between Hoover and Rowe Avenues as platted in Drennan and Seldon's LaSalle College Park Subdivision No. 7 of Lots 1 and 2 of Trombley's Subdivision of part of the south one-half of fractional Section 11, T. 1 S., R. 12 E., City of Detroit, Wayne County, Michigan, as recorded in Liber 60, Page 30 of plats of Wayne County Records, lying east of and adjoining the easterly line of the northerly 22.32 feet of Lot 2350 and lying west of and adjoining the westerly line of Lot 2269, all of the above mentioned Subdivision. (Eugene D. Shank, No. 11109).

Also, All of the east-west public alley, 20 feet wide, in the block bounded by Ward, Chippewa, Sorrento, and Pembroke Avenues, as platted in Blackstone Park Subdivision No. 6 of part of the north one-half of Section 5, T. 1 S., R. 11 E., Greenfield Township (now City of Detroit), Wayne County, Michigan as recorded in Liber 52, Page 91 of plats of Wayne County Records lying south of and adjoining the southerly line of Lots 3387 and 3486, lying south of and adjoining the southerly line of the vacated 18 foot alley lying between said Lots 3387 and 3486, and lying north of and adjoining the northerly line of Lots 3022 to 3032, both inclusive, all of the above mentioned Subdivision. (James Postel, No. 12277).

Also, All of the north-south public

alley, 20 feet wide, north of Pickford Avenue between Ashton and Southfield Roads as platted in Emerson Manor Subdivision of the southeast $\frac{1}{4}$ or the northeast $\frac{1}{4}$ of Section 11, T. 1 S., R. 10 E., Redford (now City of Detroit), Michigan, as recorded in Liber 51, Page 40 of plats of Wayne County Records, lying east of and adjoining the easterly line of Lots 235 to 248, both inclusive, lying east of and adjoining the easterly line of the 20-foot east-west public alley adjoining Lot 248, and lying west of and adjoining the westerly line of Lots 249 to 273, both inclusive, all of the above mentioned Subdivision.

Also, all of the east-west public alley, 20 feet wide, lying north of Pickford Avenue between Ashton and Southfield Roads, as platted in Emerson Manor Subdivision of the southeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of Section 11, T. 1 S., R. 10 E., Redford (now City of Detroit), Michigan, as recorded in Liber 51, Page 40 of plats of Wayne County Records, lying north of and adjoining the northerly line of Lot 248 of the above mentioned Subdivision. (Leonard A. Wulff, No. 11185).

Be and the same are vacated as public alleys and are hereby converted into public easements of the full width of the alleys, which easements shall be subject to the following covenants and agreements, uses, reservations, and regulations which shall be observed by the owners of the lots abutting on said alleys and by their grantees and assigns, and their heirs, executors, administrators, and assigns forever, to-wit:

First, said owners hereby grant to and for the use of the public an easement or right-of-way over said vacated public alleys hereinabove described for the purpose of installing, maintaining, repairing, removing, or replacing any sewer, conduit, telephone, telegraph, electric light or other poles or things usually placed or installed in a public alley in the City of Detroit, with the right to ingress and egress at any time to and over said easements for the purposes above set forth;

Second, said owners for their heirs and assigns further agree that no buildings or structures of any nature whatsoever (except necessary line fences) shall be built upon said easements;

Third, that if at any time in the future the owners of any lots abutting on said vacated alleys shall request the removal and/or relocation of any existing poles or other utilities in said easements, such owners upon whose property the poles or other utilities are located shall pay all costs incident to such removal and/or relocation, unless such

charges are waived by the utility owners.
