Gentlemen—Your Honorable Body on January 3, 1961 (1960 J.C.C. Page 2552), directed this office to institute legal proceedings in Circuit Court for the vacation of Fairview Avenue from Freud Avenue to the Detroit River.

After consideration, it is deemed advisable by all parties concerned that the new street be opened and paved before instituting the proceedings to vacate.

It is estimated that the new street improvements would cost approximately \$47,000.00. The Harbor Bar Incorporated being the owner of the property adjoining the proposed street has tendered check in the amount of \$27,700.00 as their share of the costs.

In view of the foregoing we recommend the following property be set aside for street purposes and known as Fairview Drive:

All that part of Out Lot 26 of Sub-division of Private Claim 724, The Delorme Farm, Grosse Pointe Township, County of Wayne, as recorded in Chancery File 611, described as follows:

Beginning at a point in the south line of Freud Avenue 60 feet wide as now established, said point being distant easterly 176.12 feet from the intersection of the said southerly line of Freud Avenue 60 feet wide with the westerly line of Private Claim 724; thence southerly parallel to the west line of Private Claim 724, 928.32 feet, more or less to a point; thence easterly at right angles to the west line of Private Claim 724 a distance of 16.00 feet; thence southerly parallel to the west line of Private Claim 724, a distance of 540.17 feet, more or less, to a point; thence easterly at right angles, a distance of 50 feet, more or less, to a point; thence northerly

601.53 feet, more or less to a point; thence northwesterly 101.12 feet to a point; thence northerly 827.35 feet, more or less, to a point on the south line of Freud Avenue 60 feet wide as now established; thence westerly along said southerly line of Freud Avenue 50.00 feet to the point of beginning, and that the Department of Parks and Recreation and the Department of Public Works be directed to proceed immediately with opening and improving said street.
