Gentlemen-We are returning herewith the petition of the Board of Education, No. 1135, requesting the vacation of the alley in the block bounded by Sheridan Avenue, Townsend Avenue, Lafayette Avenue and Agnes Avenue within the limits of the Field Replacement School Site. The vacation of said alley was approved by the City Plan Commission and the petition was then referred to this office by your Committee of the Whole for investigation and report.

We wish to advise that our investi-

gations are completed.

As per our directive, the petitioner issued a purchase order, No. 3394, in the amount of \$1,500.00, in favor of the Department of Public Works, Sewer Design Bureau, to cover the costs of constructing a new manhole and intercepting an existing catch basin line.

The petitioner also issued a purchase order, No. 3395, in the amount of \$261.86, in favor of the Department of Public Works, Street Design Bureau,

said amount being the original cost of paving the south one-half of Agnes Avenue and the north one-half Lafayette Avenue at the intersection of the alley to be vacated.

The petitioner also issued a pur-

chase order, No. 3396, in the amount of \$933.00, in favor of the Department of Public Works, Street Maintenance Division, to cover the costs of removing the paved alley returns, constructing new curb and walk and backfilling where necessary.

All other City departments and privately owned utility companies reported that they will be unaffected by said vacation or that they have

reached satisfactory agreements with the petitioner regarding their installations therein.

We recommend the adoption of the attached resolution.
