## Department of Public Works February 11, 1963.

Honorable Common Council:

Gentlemen-We are returning herewith the petition of the Board of Education, No. 205, requesting the vacation of Lemay Avenue south of Warren Avenue and certain alleys in the area bounded by Canfield Avenue, Montclair Avenue, Warren Avenue and Fairview Avenue. The vacation of said street and alleys was approved by the City Plan Commission with the recommendation that sufficient recommendation that sufficient land be dedicated for a new alley outlet into Montclair Avenue. The petition was then referred to this office by your Committee of the Whole for investigation and report.

We wish to advise that our investi-

gations are completed.

As per our directive, the petitioner issued a purchase order. No. 014428, in the amount of \$718.00, in favor of the Department of Water Supply, said amount being the estimated cost of abandoning an existing water main abandoning an existing water main located in Lemay Avenue to be vacated

The petitioner also issued a purchase order, No. 014429, in the amount of \$850.00, in favor of the Detroit Fire Department, said amount being the estimated cost of removing and relocating one fire hydrant located in the portion of Lemay Avenue to be vacated.

The petitioner also issued a purchase order, No. 014430, in the amount of \$600.00, in favor of the Public Lighting Division, said amount being the estimated cost of removing the P.L.C. facilities located in the area to be vacated.

The petitioner also issued a purchase order, No. 014432, in the amount of \$7,120.00, in favor of the Department of Public Works, Street Maintenance Division, said amount being the estimated cost of removing the paved street and alley returns, constructing new curb and walk, backfilling where necessary, and stoning and grading the newly deeded alley.

The petitioner also issued a purchase order, No. 014431, in the amount of \$2,853.47, in favor of the Department of Public Works, Street Design Bureau, said amount being the ori-ginal cost of paving the streets at the intersection of the streets and

alleys to be vacated.

An easement is reserved in the vacating resolution for the Public Lighting Commission for the maintenance of its installations located in a portion of Lemay Avenue to be vacated.

Proper provisions are incorporated in the vacating resolution protesting the City's interests in the sewer located in the alleys to be vacated.

We are in receipt of a Quit Claim Deed from the petitioner to the City of Detroit deeding land for a new alley outlet into Montclair Avenue. Said deed was approved as to form and and as to description by the City Engineer and is attached for your Hon-

orable Body's accepts co.

All other City departments and privately owned utility companies reported that they will be unaffected by said vacations or that they have reached satisfactory agreements with the petitioner regarding their installations therein.

We recommend the adoption of the attached resolution.

1) Provided, That by reason of the vacation of the above-described alleys, the City of Detroit does not waive any rights to the sewer located therein and at all times shall have the right to enter upon the premises, if found necessary, on acount of said sewer, to repair, alter. or service same; and further

2) Provided, That if a building is to be constructed over said sewer, the sewer shall be replaced with cast iron pipes of the same size, rerouted or enclosed in 6 inches of Class "A" concrete, or in lieu of the above, such work shall be done as will be specified by the City Engineer, all of the work mentioned to be done

under the supervision and inspection of the Department of Public Works and all costs entailed to be borne by the petitioners, their successors,

or assigns; and further
3) Provided, That no buildings shall be constructed over said sewer without the prior approval of such building construction by the City Engineer and the Department of Buildings and Safety Engineering; and further
4) Provided, That in the event that

the sewer located in said alleys, if built upon, shall break causing damage to any construction above, the petitioner and their assigns, by acceptance of the permit for building over said sewer, waive all claims for damages to such construction and agree to pay all costs incident to the repair of said broken sewer; and further

Resolved, That the Quit Claim Deed of the Board of Education to the City of Detroit for alley purposes being the southerly 20 feet of Lot 83, of St. Clair Heights, Eugene H. Sloman's Subdivision of Part P.C. 387 as recorded in Liber 18 Page 50 of Plats, Wayne County Records.

Be and the same is hereby accepted and the City Controller is hereby directed to record said Deed in the Office of the Register of Deeds for Wayne County.

## Department of Public Works February 15, 1963.

Honorable Common Council:

Gentlemen—In response to published advertisements, nine bids were received on February 5, 1963, for the Puritan Pumping Station and Back-Water Gate Chamber, Contract PW-3977, as listed on the attached tabulation.

This contract is financed in part by

a Federal Grant for sewage treatment works under the provisions of Federal Public Law 33 USC 466, et seq. in the amount of \$166,635.00. Your Honorable Body authorized and directed the acceptance of a grant in the amount of \$195,750.00 by your resolution of December 4, 1962. However, upon receipt of the actual bids, it has been determined that the total project cost will be reduced which will accordingly reduce the grant to \$166 635.00.

The low bid on this contract was regular and in accordance with the

contract requirements.

As provided in the federal regulations pertaining to this grant, the tabulation of bids received and copy of the low bidder's proposal were submitted to the United States Department of Health, Education, and Welfare. That department, through its Chicago regional office, has advised that the City was a state of th vised that the City may award the contract to the low bidder.

It is therefore recommended that the contract be awarded to the low bidder, Miller-Thompsen Construction Company, Inc., in the amount of \$278.270.00.

In addition to the contract price, it is estimated that \$26,230.00 will be required to cover the cost of advertising, inspection, and possible minor changes, making the total funds required \$304,500.00 Funds are available in Account Number 530-9650-910 which, with the addition of the Federal Grant of \$166,635.00, is sufficent to cover the total estimated cost.
