Your Honorable Body may make provisions for the relocation of the lines and poles of the Detroit Edison Company and the Michigan Bell Telephone Company in streets located near the street and alleys to be va-

The Corporation Counsel contends that these relocating costs are not chargeable against the City. The case involving the liability of the City for these costs is now pending in the Michigan Supreme Court.

The low bid was regular in all respects and in accordance with the requirements of the Contract Docu-ments. It is, therefore, recommended that the contract be awarded to the

low bidder, DiMambro Contractors, Inc., in the amount of \$27,800.00.

It is estimated that \$31,800.00 will be required to cover the cost of the contract, as well as the cost of advertising, inspection and minor contingencies.
