Honorable Common Council: Gentlemen - We wish to advise that in carrying out the development plan for the rehabilitation of the blighted area which is known as the Elmwood Park Project No. 1, Michigan R-40, which is being undertaken by the City pursuant to Act 344 of Public Acts of 1945, as amended, the Detroit Housing Commission (No. 5994) has requested the vacation of the remaining streets and alleys within the limits of said project.

The Detroit Edison Company has reported that it has lines and poles in the streets and alleys to be vacated and has submitted an estimate of \$23,191.00, as its cost of removing and rerouting its installations from the remaining streets and alleys to be vacated within the Elmwood Park

Project No. 1.

The Michigan Consolidated Gas Company has reported that it has gas mains located in the remaining streets to be vacated and has submitted an estimate of \$8,740.00, as its cost of abandoning the gas mains

within the limits of the project.
Your Honorable Body may make previsions for the relocation of the lines and poles of the Detroit Edison Company and the gas mains of the Michigan Consolidated Gas Company in streets located near the streets and

alleys to be vacated.

The Corporation Counsel contends that these relocating costs are not chargeable against the City. The case involving the liability of the City for these costs is now pending in the Michigan Supreme Court.

All City departments reported that they will be unaffected by the vacation of said streets and alleys.

In view of the foregoing, it will be necessary to adopt a resolution vacating the remaining streets and alleys in the Elmwood Project No. 1 and directing the Detroit Edison Company, the Michigan Bell Telephone Company and the Michigan Consolidated Gas Company to remove their installations therefrom.

Honorable Common Council: Gentlemen—We are returning herewith the petition of Clarence G. Ringley, No. 7364, requesting the va-cation of a portion of east-west public alley south of Baltimore Avenue and west of Brush Street. The vacation of said portion of alley was approved by the City Plan Commission with the recommendation that the petitioner deed to the City a similar portion of property for alley purposes. The petition was then re-ferred to this office by your Commit-tee of the Whole for investigation and report.

We wish to advise that our investi-

gations are completed.

Proper sewer provisions are incorporated into the vacating resolution protecting the City's interests in the sewer located in the portion of the

alley to be vacated.

We are in receipt of a Quit Claim deed from the petitioner to the City of Detroit deeding land for alley purposes in accordance with the City Plan Commission's recommendation. Said deed was approved as to form and execution by the Corporation Counsel and as to description by the City Engineer and is attached hereto for your Honorable Body's acceptance.

All other City departments and privately owned utility companies reported that they will be unaffected by the vacation of the above-mentioned portion of public alley.

We recommend the adoption of the

attached resolution.
