Gentlemen-We are returning herewith the petition of the Board of Education, No. 3615, requesting the vacation of all the streets and alleys in the area bounded by Townsend Avenue, Van Dyke Avenue, Conger Avenue and the Edsel Ford Freeway. The vacation of said streets and alleys was approved by the City Plan Commission with the recommendation that sufficient land be dedicated for the widening of Van Dyke Avenue.
The petition was then referred to this office by your Committee of the Whole for investigation and report.

We wish to advise that our investi-

gations are completed.

As per our directive, the petitioner issued a purchase order, No. 045612, in the amount of \$5,235.00, in favor of the Department of Water Supply, to cover the costs of abandoning their existing water mains located in the streets to be vacated.

The petitioner also issued a purchase order, No. 045613, in the amount of \$1,450.00, in favor of the Detroit Fire Department, said amount being the estimated cost of removing or relocations there. relocating three fire hydrants from the area to be vacated.

The petitioner also issued a pur-

chase order, No. 045614, in the amount of \$12,000.00, in favor of the Public Lighting Commission, Communications Division, to cover the cost of building a new duct and relocating its cable from the area to be vacated.

The petitioner also issued a pur-chase order, No. 045615, in the amount of \$1,200.00, in favor of the Public Lighting Commission, Lighting Divi-sion, to cover the cost of removing and relocating its facilities from the
