Gentlemen — We are submitting for your consideration, copy of an agreement prepared by the Wayne County Road Commission which provides for the widening and reconstruction of Schoenherr Road between Seven Mile Road and Eight Mile Road.

For some time, the need has existed for an improvement on Schoenherr Road between Seven and Eight Mile Roads in order to eliminate a particularly serious drainage and flooding problem and to adequately handle traffic. The City has been unable to undertake this project because of insufficient funds in our Assessment

Street Paving Budget.
The Wayne County Road Commission has agreed to undertake this project at their entire cost and have provided funds in their current budget. The improvement is scheduled for the 1965 construction season. The work will consist of a new 44-foot wide pavement, with integral curb, which width will match the existing pavement width south of Seven Mile and North of Eight Mile Road. No additional right-of-way is required since the widened pavement can be constructed within the present property lines.

Among other things, the agreement

provides as follows:

a) The Wayne County Road Commission will undertake the project at their cost during the 1965 construction struction season, consisting of the widening and reconstruction of the existing Schoenherr Road to a curbed 44-foot wide pavement from Seven Mile to Eight Mile Road.

b) The project will be constructed in such a way that Schoenherr Road traffic will be maintained in a satis-

factory manner.

- c) The City will be responsible for any necessary removal and/or relocation of any City-owned utility facility and major structural changes including the cost incurred for outlet sewers, except the cost of raising and lowering manholes, catch basins and other such work which is usually considered incidental to paving projects.
- d) The Wayne County Road Com-mission will not assume legal jurisdiction of this portion of Schoenherr Road.
