Honorable Common Council:

Gentlemen-We are returning herewith petition of the Detroit-Wayne Joint Building Authority No. 915 requesting the vacation of a six-foot wide strip of the right-of-way from the easterly side of Raynor Avenue between Clinton and Gratiot. The vacation of said street was approved by the City Plan Commission and re-ferred to this office by your Committee of the Whole for investigation and report.

We wish to advise that our investi-

gations are completed.

The Detroit-Wayne Joint Building Authority has submitted letters of agreement to reimburse the Board of Fire Commissioners and the Public Lighting Commission for the actual costs including overhead involved in relocating their facilities in Raynor Street. These letters have been approved by the respective departments and are filed with the petition.

The Building Authority has filed a letter from their Architects stating that the present curb and paving widths in Raynor Avenue will be maintained as requested by the

Police Department.

All other City departments and privately owned utility companies ported that they will be unaffected by the vacation of said right-of-way.

All of the easterly six feet of Raynor Street between the north line of Clinton Street and the south line of Gratiot Street as opened through land platted in the Plat of the Antoine of Beaubien Farm, Detroit, City Wayne County, Michigan, as recorded on April 22, 1846, in Liber 27, Page 197 of Deeds Wayne County Records, and lying west of and adjoining the Lot 8 of said subdivision and public lands known as Clinton Park, the deed to which is recorded on December 29, 1868, in Liber 137 Page 55 of Deeds Wayne County Records.

Be and the same six foot strip is hereby vacated as a public street to become a part and parcel of the ad-

joining property.
