IT IS HEREBY ORDAINED BY THE

PEOPLE OF THE CITY OF DETROIT: Section 1. That Chapter 55, Article 3 of the Code of the City of Detroit be amended by amending Section 55-3-2, to read as follows:

Sec. 55-3-2. No person shall operate or cause to be operated within the city any business commonly known as the secondhand or used automobile business; used auto parts business; or the operating of a business for dismantling or wrecking of automobiles for junk and salvage without first obtaining a license therefor from the mayor and complying with the terms of this article. NO LICENSE SHALL BE ISSUED UNTIL AN INSPECTION RE-IS RECEIVED FROM THE DEPARTMENT OF BUILDINGS AND SAFETY ENGINEERING.

Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed only to the extent necessary to give this ordinance full force and effect.
