requested conversion easement for public utilities was recommended by the City Plan Commission. The petitions were then referred to us for investigation and report. Our report, accompanied by the original petition is as follows:

The petitioner has requested that the paved return at the entrance to the alley to be vacated and the Fisher Freeway South Service Drive remain in its present status as the petitioner plans to utilize same, and had agreed by letter filed with the original petition to pay all costs incidental to the removal of same whenever the discontinuance of use makes such removal necessary.

All City departments and privatelyowned utility companies reported that they will be unaffected by the conversion to an easement of said alley or that they have reached satisfactory agreements with petitioner regarding their installation therein.

Field's Subdivision of part of Private Claim 67. Springwells, Wayne County, Michigan as recorded in Liber 7, Page 62, Plats, Wayne County records, lying easterly and abutting the easterly line of Lot 29, and the southerly 9.20 feet of Lot 30, and lying westerly of and abutting the westerly line of Lot 70 and the southerly 11.71 feet of Lot 69, inclusive of the above mentioned subdivision,

Second, said owners for their heirs and assigns further agree that no buildings or structures of any nature whatsoever including but not limited to concrete slabs or driveways. retaining or partition walls (except necessary line fence) shall be built or placed upon said easement, nor any change of surface grade made. prior approval by the without Department of Public Works.

Third, that if at any time in the the owners of any lots future abutting on said vacated alley shall request the removal and/or relocation of any existing poles or other utilities in said easement, such owners, upon whose property the poles or other utilities are located shall pay all costs incidental to such removal and/or relocation, unless such charges are waived by the utility owners.

Provided Further, that if any utility located or to be located in said property shall break or be damaged as a result of any action on the part of the petitioner or assigns (by way of illustration but not limitation), such as storage or excessive weights of materials or construction not in accordance with Section 2, mentioned above, then in such event the petitioner or assigns shall be liable for all costs incidental to the repair of such broken or damaged utility.
