Gentlemen — The above petition requests the vacation of the northof Harper and east of Woodward. The requested vacation was approved by paid by the petitioner, his heirs,

the City Plan Commission. petition was then referred to us for investigation and report. Our report, accompanied by the original petition, is as follows:

The petitioner has made the following deposits with the Treasurer, which have been credited to the departments and accounts named, for the purposes indicated: Public Lighting Commission Fund 990-9423; Receipt No. A - 4 3 3 1 0; \$1,225.00 for the estimated cost of removing two overhead power poles, approximately 300 feet of 2-7500 V cables, two handhole covers and rings, and the installation of two alley lights on Detroit Edison Company poles; Department of Public Works (Street Maintenance Division) Fund 143-6241; Receipt No. B-35675; \$152.00 for the original cost of paving the north one-half of Harper Avenue at the intersection of the alley to be vacated.

The petitioner has also requested that the paved return at the entrance to the alley to be vacated, intersecting Harper Avenue, remain in its present status as the petitioner plans to utilize same and had agreed by letter filed with the original petition to pay all costs incidental to the removal of same whenever the discontinuance of use makes such removal necessary.

All other involved City departments and privately-owned utility companies reported that they have no objection to the proposed vacation or that they have reached satisfactory agreements with the petitioner regarding their installations therein.
