0289—Request for Change Order. Gentlemen — On June 4, 1968 (JCC 1176-7), your Honorable Body approved the award of the subject contract to General Piping, Inc., at a cost of \$5,666,000.000.

During the construction of the first cell of the temporary cellular cofferdam in Lake Huron, the contractor questioned the accuracy of the soil boring information available. After discussion with our consulting engineers, it was decided to have one additional shallow soil boring made. The boring was made by Raymond International, using the contractor's marine facilities.

General Piping submitted a quotation of \$35,334.00 as the cost for labor and equipment to make this boring. This quotation was reviewed and the price found to be unreasonable.

During the time the work was being performed, records were kept of the labor and equipment involved. Based upon Article 17, Changes In Work, of the General Conditions, and using the contractor's payrolls and normal equipment rental rates, the "Actual Cost" was determined to be \$9,246.00 — including the prescribed percentage for overhead and profit. That amount was approved by the Board of Water Commissioners at its meeting of December 16, 1968.
