Re: Petitions 5912 and 7237, Street and Alley Vacations, Detroit Housing Commission.

Gentlemen—We wish to advise that in carrying out the development plan for the area known as the Elmwood Park No. 2 Project, Michigan R-62, which is being undertaken by the City pursuant to Act 344 of the Public Acts of 1945, as amended, the Detroit Housing Commission (5912 and 7237) has requested the vacation of the streets and alleys in the area bounded by the Grand Trunk Railroad Right of Way, Chene Street, Larned and Lafayette Avenues.

The Detroit Edison Company has reported that it has lines and poles in the streets and alleys to be vacated which will have to be removed and rerouted.

The Michigan Bell Telephone Company has reported that it has lines and poles in the streets and alleys to be vacated, which will have to be removed and rerouted.

The Michigan Consolidated Gas Company has reported that it has mains in the streets and alleys to be vacated which will have to be rerouted.

Your Honorable Body may make provisions for the relocation of said mains, lines, and poles of the Detroit Edison Company, the Michigan Bell Telephone Company, and the Michigan Consolidated Gas Company to streets and alleys near the streets and alleys to be vacated.

The Corporation Counsel contends that any costs incurred in the relocation of equipment from the streets and alleys to be vacated are not chargeable against the City. The case involving the liability of the City is now pending.

All other involved City departments reported that they have no objection to the proposed vacations, or that they have reached satisfactory agreements with the petitioner regarding their installations therein.

The adoption of the attached resolution is recommended.

(3) Public utilities shall not be installed on surface but only underground and no buildings or structures of any nature whatsoever (except necessary line fences) shall be built or placed upon said easement; and be it further

Resolved, That the Detroit Edison Company and the Michigan Bell Telephone Company are hereby directed to remove all their overhead lines and poles from the vacated streets without expense to the City within thirty (30) days after receipt of a copy of this resolution; and be it further

Re: Petition No. 6529, Michigan Consolidated Gas Company, Vacation of Stimson Street between Brooklyn and Lodge Freeway and Alleys in the same block south of Stimson.

Gentlemen—The above petition requests the vacation of Stimson Street, 80 feet wide, between Brooklyn and the John C. Lodge Freeway, and the vacation of the alleys and the public utility easements in the block bounded by Brooklyn, the John C. Lodge Freeway, Nobel and Myrtle Avenue.

The requested vacations were recommended by the City Plan Commission.
